MISSION OF AME

- In Hungary, about 12% of the education sector operates privately (non-state and non-church). Nearly 15% of them are already members of the Association of Hungarian Independent Schools (AME).
- We believe that it is increasingly important for privately run institutions close to education to be represented as a community.
- Since 1992, our association has been the **legal and advocacy organization** of foundation and private educational institutions, NGOs operating in the field of education, as well as the maintainers of these institutions, which is based on the principle of democratic self-government and operates as a legal entity.
- The Association of Hungarian Independent Schools has almost 80 members, from kindergarten to secondary schools, from private institutions to art schools. Membership can be obtained by any educational institution that is maintained by legal entities, private individuals or non-governmental and non-clerical organizations that agree with its aims.

MAIN TASKS OF AME

- The Association creates opportunity for the schools to express opinions on different processes and decisions concerning them. It also provides a forum for discussing and solving their problems. It advocates the interests of the institutes, forms, and communicates views and suggestions on laws-in-progress concerning their activities and protects the schools from any kind of distinctive efforts.
- The Association regularly **organises** conferences, forums, meetings, and other professional programmes in accordance with the demands of its members. On these occasions the central topic of discussion can be actual professional problems just as general questions of operations or pedagogy.
- The Association had worked out its own self-evaluation-based system of quality insurance containing high standard criteria.
 Its board of independent experts advances and judges the results of the self-valuation process and awards the prize of "Qualified School/Kindergarten of the Association of Hungarian Independent Schools" for institutions fulfilling the criteria.
 The Association also assists both operating and newly established schools with professional advising, consultation, judicial aid and economical counsel.
- We are an active member of the European Council of National Associations of Independent Schools (ECNAIS) and the European Federation of Education Employers (EFEE).



What do we offer to our members?


- receive direct information about news affecting the sphere through the association.


Educational institution, Hungary (4 323)




Non-state and non-church educational institutions, Hungary (528)
